



# **TISCA Water Polo North Region**

## **Consolidated Championship - April 19, 2014**

**Date:** Saturday, April 25<sup>th</sup>. Games will begin no earlier than 8:00 am and end no later than 5:00 pm.

**Location:** To be Determined

**Divisions:** All teams not selected for the Region Championship, Consolidated Teams, & Coed teams will compete in the Consolidated Champs on Saturday, April 24<sup>th</sup>. The top 12 boys and top 12 girls teams selected to participate in the Region Champs will be announced/emailed to everyone on Sunday night, April 12<sup>th</sup>.

- **Boys/Coed Consolidated Division**

**Entry Deadline: Sunday, April 19<sup>th</sup>.** Teams have been placed in divisions (Region Teams or Consolidated Teams) based on play this season. To change divisions or be added to the Consolidated Championship Divisions, teams must email [ccullen@dentonisd.org](mailto:ccullen@dentonisd.org) by Sunday, April 19<sup>th</sup>. Please include team names and divisions.

**Format:** The tournament will be championship style format with advancement and placing games. All games and tie-breaker situations will use NFHS regulations unless noted. Each game will be 4 x 5:00 minute quarters. There will be two minutes between quarters for all games. If needed, games tied after four quarters will play a sudden victory period. All teams get two timeouts per game (plus an extra time out for overtime). First team listed wears white caps & starts to the left of the table. All teams will play at least two games.

**Game Schedule:** On Monday, April 20<sup>th</sup> an email will be sent to all coaches listing teams playing and the schedule for the North Region Consolidated Championship.

**Entry Fee:** \$150 per team entered (\$300 for boys & girls teams). **Make checks payable to TISCA Water Polo-North Texas Region.** Please send payments to Stephanie Klocke, 2932 Chris Lane, Grapevine, TX 76051.

**Rosters:** Please use the North Region Roster Template and email rosters to [ccullen@dentonisd.org](mailto:ccullen@dentonisd.org) by Wednesday, April 22<sup>nd</sup>. Please include cap number, name, & grade in school for each athlete. There will be a no roster limit for the North Region Consolidated Championships.

**Table Workers:** Each team will need to supply TWO table workers for each game they play. Table workers can be JV players, parents, or alternate gender players. Please have the players report to the respective table 10 minutes prior to the start of the game they are working. Games will NOT begin unless teams supply table workers!!!!

**Awards:** There will be 1<sup>st</sup> Place Awards given for the Boys and Girls Divisions at Consolidated Championship.

**Admissions:** There will be an admission of \$5 for adults and \$3 for students. For children 10 & under, there will be no admission charge.

**Hospitality:** There will be hospitality for all coaches & officials.

**North Region Coaches Committee:** This committee will resolve all disputes related to the North Region Championships and Consolidated Championship. The committee consists of Chris Cullen, Dan Snow, Paul Wallace, Xio Lopez, and Mihai Oprea. Protests must be lodged by an involved coach within 15 minutes after the end of the game in question to the Head Referee.

## **TISCA Water Polo North Region Tournament Rules & Regulations**

### **Natatorium/On Deck Rules & Regulations**

- Absolutely NO deck changing. All teams MUST use the locker rooms to change before/after games.
- Folding Chairs are not allowed in the Spectator area. The walkways must stay clear at all times.
- All deck photographers must be pre-approved by North Texas Region Committee
- Spectators are required to remain in the spectator areas at each pool location. Spectators, on deck during competition, are not permitted.
- Each competing team is permitted one temporary banner, placed at the discretion of the Aquatics Director. No other banners, posters, or other decorations are permitted.
- Glass containers of any sort and chewing gum are not permitted anywhere within the Aquatic Center.
- Spectators may not bring food and/or drink into the Aquatics Center from outside sources. Athletes ARE permitted to bring food and drink on deck.
- The use of tobacco products and the possession or consumption of alcoholic beverages is prohibited on all Aquatics Center Property
- Artificial noisemakers and laser pointing devices of any sort are not permitted anywhere within the pool areas in accordance with Federation Policies.
- Teams are expected to police their respective areas at the beginning, during, and at the conclusion of the competition.
- Running or any other sort of activity that might be interpreted or described as “horseplay” is prohibited throughout either pool area.
- Only authorized personnel are permitted access pool deck and team locker rooms.
- No Face Painting Allowed on the Premises.
- Access to the deck of the pools is restricted to the following:
  - Athletes from competing teams
  - Administrative support personnel
  - Coaches of competing teams Facility/District Staff
  - Officials working the tournament.
